## Patient insurance coverage verification outline.

Dear prospective patient seeking coverage verification, or existing patient with a change of insurance plans:

Thank you for your interest in becoming a patient of Dr. Hutchins at Hutchins Naprapathic Clinic, P.C. Many insurance plans have coverage for naprapathic care. Insurance carriers write numerous plans, with differing types, and levels of coverage. Additionally, they have varying deductibles and copays, etc. It is not possible for me to answer if your plan has coverage for my services based on the Provider name (Blue Cross, Aetna, etc.) due to the thousands of plans that they administer.

My office will be happy to submit your claims on your behalf, and provide whatever information we can to help you get the best possible coverage. It is important for you to understand that your insurance coverage is a contract between you, your insurance company, and possibly your employer or other group. Hutchins Naprapathic Clinic, P.C., and Dr. Hutchins are not a party to that contract, and have only limited rights concerning your coverage. Contacting your insurer directly, and making record of the phone call is by far the best way to ensure that you have clear understanding of your coverage for any type of health care provider, and disputing any issues regarding your claims.

This form will serve as a guideline for communicating with your insurer directly, and may be valuable should there be any dispute of your claim. The telephone number to call to discuss your coverage is usually on the back of your insurance card.

Following is a list of information that should help identify my practice with your insurer, and a list of some of the codes I may use, as well as important questions to ask. I recommend that you fill out the answers in the lines provided in case you need them for future reference.
